1. Introduction:

Nepal Telecommunications Authority was established on March 4, 1998 as an autonomous regulatory body within the framework of the [Telecommunication Act 1997 A.D.](#) and Telecommunication Regulation 1997 A.D.

As per the section 13 of the Telecommunications Act 2053 B.S. (1997 A.D.) the functions and duties of the Authority are as follows:

- (a) To provide suggestions to Government of Nepal on the policy, plan and program to be adopted by Government of Nepal for the development of the Telecommunications Service.
- (b) To make the Telecommunications Service reliable and easily available to the public.
- (c) To make necessary arrangement to avail basic Telecommunications Service and facilities in all rural and urban areas throughout Nepal.
- (d) To involve the national and foreign private sector investors in the operation of the Telecommunications Service.
- (e) To make arrangement for the coordination and healthy competition among the persons providing Telecommunications Service and facilities, so as to provide such service and facilities to all public in general.
- (f) To prescribe, fix and approve the standard and quality standard of the plant and equipment relating to the Telecommunications and the Telecommunications Service.
- (g) To regularize and systematize Telecommunications Service
- (h) To grant License to operate the Telecommunications service.
- (i) To approve and regularize the fees to be collected by a person having obtained License for providing the Telecommunications Service.
- (j) To perform the functions relating to the frequency in accordance with the policy determined by the Radio Frequency Policy Determination Committee.
- (k) To carry out or cause to carry out the research about the development and use of new technology in the field of Telecommunications.
- (l) To cause to develop the skilled manpower for the Telecommunications Sector.
- (m) To develop and extend or cause to develop and extended the Telecommunications Service in such a way that it protects the rights and interests of the consumers.
- (n) To develop or cause to develops Nepal as an International Transit for Telecommunications.
- (o) To carry out necessary and appropriate functions for the development and promotion of the Telecommunications Service.

2. NTA activities during the month of Magh 2064 (15 January - 12 February, 2008):

- 2.1. On the complaint filed by Mr. Madhav Vikram Thapa against Nepal Doorsanchar Company Limited on "trying to collect undue fee for the service that was not used", the Authority has decided that there is no condition to suggest that the petitioner should not pay the mentioned fee as

there is no evidence to suggest that there was any technical error as suggested by the Judicial Committee after consultation.

2.2. Authority's Major Decisions in the month of Magh 2064 (16 January - 12 February, 2008):

2.2.1. The tariff of mobile service of Nepal Doorsanchar Company limited has been approved as follows to be effective from 1st of Falgun, 2064.

2.2.2. As M/s Worldlink Communications Pvt. Ltd. has published the tariff rate in different newspaper without getting approval from the Authority in violation of the rule 42 of the Telecommunication Act 2053 and

clause 5 of the Annex in its license, Worldlink Communications has been asked to submit its clarification within fifteen days.

- 2.2.3.** The license of M/s STM Telecom Sanchar Pvt. Ltd. has been amended as proposed by the management.
- 2.2.4.** The guideline for recently opened "Network Service" has been approved.
- 2.2.5.** As per the sub-rule (1) of rule (17) of Finance Act 2064, Internet Service Providers (ISPs) are exempted from paying Telecom Service Charge. But after the decision of NTA to open the Internet Telephony service to be provided by ISPs, ISPs now not only transfer data but also voice telephony, it has been decided to seek the necessary directive from Ministry of Finance through Ministry of Information and Communication as per the rule 17(1) of the Finance Act 2064.
- 2.2.6.** As M/s Worldlink Communications Pvt. Ltd. has published the tariff rate in different newspaper without getting approval from the Authority in violation of the rule 42 of the Telecommunication Act 2053 and clause 5 of the Annex in its license, Legal section of NTA has been directed to prepare a decision that will levy a fine of Rs. 1 to Worldlink Communications Pvt. Ltd. as per the rule 47(1) of the Telecommunication Act 2053.
- 2.2.7.** NTA management has been directed to prepare a Finance Policy of NTA and submit it for approval.
- 2.2.8.** License for Limited Mobility Service based on wireless telecommunication to be operated in specified area has been awarded to M/s United Telecom Limited in Morang and Sunsari District and the Tariff rate for that service has been approved as below. License will be issued after taking the necessary license fee as per the rule.

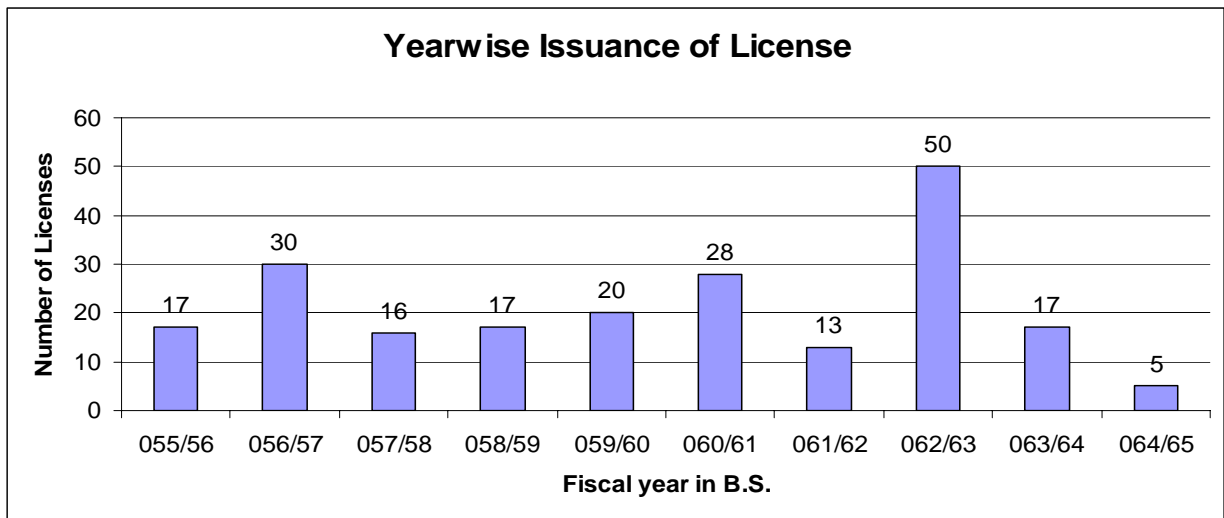
