5. Pre-bid meeting shall be held at Nepal Telecommunications Authority, Kamaladi, Kathmandu, Nepal at 24th November, 2020 at 14:00 Hr.
6. Electronic bids must be submitted to the office Nepal Telecommunications Authority, Kamaladi, Kathmandu, Nepal through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 Hr on 14th December, 2020. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14th December, 2020 at 12:30 Hr at the office of Nepal Telecommunications Authority, Kamaladi, Kathmandu. Bids must be valid for a period of 90 days counting from the date of bid opening and must be accompanied by a bid security, amounting to a minimum of NRs. 7, 50,000.00, which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. Nepal Telecommunications Authority will not be responsible for any costs or expenses incurred by bidders in connection with the preparation or delivery of Bids.
