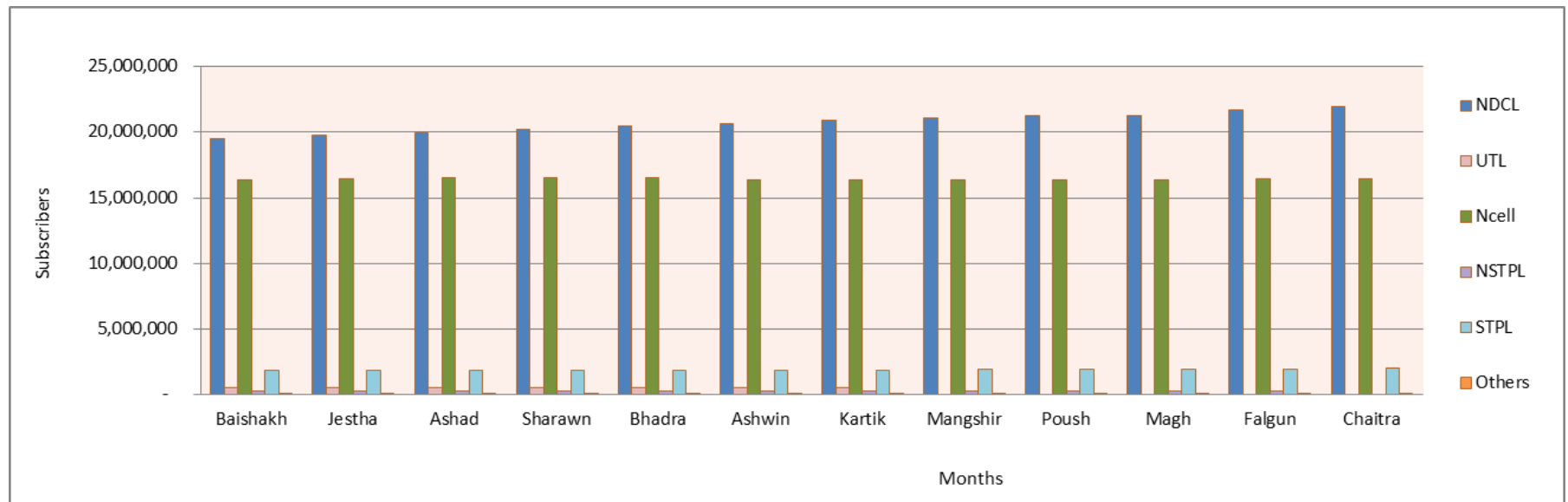


### Growth Trend of Voice and Data Services
